Neighbourhood Plan.

All members of the steering group are working on their tasks in preparation for the next meeting on 27 April at which they will be discussing the next round of questionnaires for the village. Minutes from meetings will be available to read on the website or available from the clerk upon.

IGas Tinker Lane Community Liaison Group.

A Notice Request of Planning Application has now been displayed at the site and advertised locally. The chair and the clerk attend the meetings to keep a watching brief on movements. There are to be two open sessions with a balanced view of information stands. The first will be held in Barnby Moor Village Hall on Saturday 7th May 11am-4pm and a second in Sutton Village Hall on Saturday 4th June 11am – 4 pm. Both are 'drop in' sessions.

Police Priority Setting Meeting.

Cllr Powell attended the meeting. The priorities highlighted were: speeding, car burglaries and fly tipping. Thefts had increased from 129 to 209 in a three-month period for the area.

Central Bassetlaw Forum.

The clerk attended the meeting where Steve Brown from BDC gave an update on the Devolution Bid to Sheffield City. The Secretary of State is expected to agree to it as early as September this year when a Mayor will be elected. The group voiced concerns that no public consultation had been made.

Tinker Lane planning application was discussed. IGas arranged a visit to Doe Green in Warrington to see a working coal bed methane site, which will give a flavour of a shale gas site should the gas be found and planning granted.

NCC Waste Recycling Centre Registration was discussed. A letter written by the North Notts Bassetlaw Forum was given to each Parish to use appropriately.

BDC are considering a Garden Waste Collection service. There will be a consultation.

Linghurst Lakes.

The Linghurst committee recently installed two benches (made by Alan Marsh) with money donated by BDC for all villagers to enjoy the views over the lakes in comfort.

The fence, vandalised by the quad bikes, was replaced at the same working party.

04.16.13 Village Update / Matters to Report

Cllr Wilson MacCormack joined the meeting at this point. Sadly, work commitments dictate he will no longer be able to carry out his duties as a Parish Councillor so had to resign. He will however be available to consult on any planning issues if necessary and will try and attend as many Neighbourhood Plan Steering Group meetings as possible. The chair congratulated Mike on his new role and thanked him for his work to date. The clerk will inform BDC of a Casual Vacancy. **Action Clerk**

Cllr Fowler told the meeting a resident of Chainbridge Road had an ASBO by A1 Housing served to them. No further details were given. She also told the meeting the bench in memory of Tony Storey was in her possession, awaiting installation somewhere. The PC suggested a spot on the playing field. Cllrs Fowler, Jones and Powell will have a site meeting to finalise. **Action: Cllrs Jones Powell and Fowler.**

D Cllr Taylor reminded the meeting of the forthcoming election.

Cllr Holgate has been made aware of Public Protection Order that has been served on a resident to remove dog faeces from Neatholme Lane. The dog warden has also been made aware and a careful watch will be made by the Environmental Health Officer over the next few weeks. Cllr Holgate has also been asked if a defibrillator was viable for the village. The general feeling was that it would not be effective in this village for various reasons. Cllr Fowler suggested a First Aid course may be more beneficial and agreed to research the cost and a trainer. **Cllr Fowler**
