- Dog Fouling. Cllr Nicholson attended a meeting at Idle Valley reserve where dog fouling was discussed. It was thought Lound was not as much a problem as the Belmoor area. They were told of the newly positioned bins in Lound and how they appeared to be helping. IV staff will consider installing them around the car parking areas. The PC are to be invited to meet the staff at the reserve for a walk around. Cllr Nicholson will liaise with them and suggest dates at the next PC meeting. **Action Cllr Nicholson**
