# 06.16.13 Village Update / Matters to Report

Grass Cutting: Cllr Powell has spoken to Holmes Groundcare about the condition of the playing field extension grass. It was agreed it would benefit from an additional cut each month (at an

additional cost) so the PC asked him to instruct them to do so. The moles will be dealt with over the winter months. **Action Clir Powell** 

Cllr Nicholson has heard rumours that there is planned expansion to the area surrounding Charcon, and that it will be developed into a large industrial estate. Linked to this, apparently Chainbridge Lane will be surfaced and opened to through traffic, and another road will be put through to the site from North Road near Idle Valley. D Cllr Taylor has not heard of any such plans and wonders if they are connected to the North Road expansion of the industrial estate and subsequent addition of a roundabout between Randall Way and Idle Valley entrance.

Cllr Jones asked that the pothole on Chainbridge Lane be reported along with the two leaks adjacent to the Charcon offices and yard entrance. **Action Clerk** 

Cllr Holgate asked that the unstable road outside 65 Town Street, where various road works have taken place, be reported to NCC Highways. **Action Clerk** 

Cllr Holgate asked the clerk for an update from the Lengthsman about the painting of the Reading Rooms. **Action Clerk** 

The Lengthsman's task for next year is to make a more accessible entrance to the playing field from the temporary access at the lower end of the field off Town Street. **Action Clerk**
