3. If any election is contested the poll will take place on Thursday, 2nd May 2019.
4. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Queen's Buildings, Potter Street, Worksop, Nottinghamshire, S80 2AH by 5 pm on Monday, 15th April 2019.
5. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Queen's Buildings, Potter Street, Worksop, Nottinghamshire, S80 2AH by 5 pm on Wednesday, 24th April 2019.
6. Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5 pm on Wednesday, 24th April 2019, must reach the Electoral Registration Officer at Queen's Buildings, Potter Street, Worksop, Nottinghamshire, S80 2AH by 5 pm on Thursday, 2nd May 2019.
