Residents express concerns that they had been made to feel excluded from the village for many years, that certain pockets of residents don't receive the Cryer or village communication or invites to events. That the siding up by NCC had made the pavement slippery and hadn't been completed in sections. That they had drainage issues not being addressed on Mattersey Road and that they hadn't been consulted on the position of the planters. They request one to be placed at the entrance of the Daneshill/Mattersey junction to ensure their inclusion in the scheme.

They suggest that the Parish Council serves the village and not the Parish.

The residents are directed to the village website to ensure they receive all village communications, to Notts County Council in relation to their drainage issues and highway issues and it agreed that the planter siting suggestion would be included in part of the appraisal process with NCC. It is suggested to the residents that they might consider joining the Village Hall Committee.
