22/01669/HSE | Application for Storage Building, Pump House and Hardcore Standing Areas (Retrospective) | Stonelake Chainbridge Lane Lound Nottinghamshire DN22 8RU - OBJECT on the basis that the land is SSSI/Nature reserve, not in keeping with the village design, outside of the Neighbourhood plan consideration, within the flood zone, ill designed, not suitable as a residential dwelling or considered a sustainable location. To be noted within the response that the PC are disappointed in the approach of the landowner in submitting applications retrospectively without consideration for the area.
