Village Green: Our group of five regular garden volunteers are very pleased with the garden and enjoy maintaining it as a natural wildlife space. There is a good social aspect to the working together and we learn from each other different gardening skills. I am looked on a chief designer but try to involve others to contribute ideas to help things along.

The daffodil and tulip bulbs which were salvaged from the round planters are now all planted in the garden. Along with all the previous bulbs planted, this next spring will have some very colourful displays. Not a lot of use for most wildlife but very good for the Lound residents, especially the Care Home across the road.

The paths have been more challenging this year with the unusual weather patterns but will be kept maintained by Strimming and raking to keep the vegetation down not eliminated. No chemical control is allowed. First rule of wildlife gardening.

The Christmas tree finds the conditions too dry at times but still looks ok apart from a close inspection. The replacement for the old ash tree, the Liquid amber is looking very healthy and growing fast, it's leaves will turn very red this autumn giving an autumn display.

We look forward to progressing the garden along the semi wild route but keeping it acceptable to residents walking by.
